The Graduate Diploma of Early Childhood Education at Australis is designed for individuals who want to make a meaningful impact in the lives of young children and their families.

This course offers more than just academic knowledge. It provides the practical tools, professional experience and critical thinking skills needed to step confidently into early childhood teaching roles.

Some of the reasons students choose this course include:

- ACEQCA-approved qualification that meets the requirements for early childhood teaching roles in Australia.
- Integrated professional experience with 60 days of supervised placement embedded into the course.

Whether you are building on prior study or returning to learning after time in the field, this course has been designed to equip you with the skills, confidence and understanding to thrive as an early childhood teacher.

Professional Accreditation

The Graduate Diploma of Early Childhood Education (GDECE) is on the Australian Children's Education & Care Quality Authority (ACECQA) list of approved early childhood teaching (ECT) qualifications.

This means the course meets the national requirements for early childhood teaching and is recognised for employment in approved early childhood education and care settings across Australia.



Course Overview

The Graduate Diploma of Early Childhood Education is a one-year postgraduate course designed for individuals seeking to become qualified early childhood teachers in Australia.

The course consists of eight core units, each carrying a 10 credit point weighting. Two of these units include supervised professional experience placements totalling 60 days in early childhood settings.

The course is delivered face-to-face at Australis' Melbourne campus and is designed to be completed in:

- One year (full-time) or
- Two years (part-time) for eligible domestic students

International students are required to undertake the course on a full-time basis.

Entry Requirements

To apply for the Graduate Diploma of Early Childhood Education, applicants must meet both the academic and English language requirements below.

Academic requirements

You must have successfully completed one of the following:

- An Australian bachelor degree (or equivalent qualification at AQF Level 7), or
- A Diploma of Early Childhood Education and Care (AQF Level 5), plus:
 - Evidence of at least two years of recent professional experience in early childhood education, ideally in leadership roles
 - Evidence of continued professional development or practice if your diploma
 was completed more than ten years ago

English language requirements (International students only)

You must provide evidence of English proficiency through one of the following:

- IELTS (Academic): Overall score of 6.5, with no band lower than 6.0
- TOEFL iBT: Overall score of 79, with a minimum of 24 in writing



PTE Academic: Overall score of 58, with no skill below 50

Please note that international students must demonstrate that their English language test was successfully completed within two (2) years of their date of application for admission.

What You Will Learn in This Course

The Graduate Diploma of Early Childhood Education has been designed to equip students with the professional knowledge, practical skills, and critical understanding required to become effective early childhood teachers.

Students who successfully complete the Graduate Diploma of Early Childhood Education will be able to:

- Synthesise evidence-based practices to promote inclusive curriculum, pedagogy and assessment that facilitate and embrace the individual child's curiosity, strengths, developmental needs and identity.
- 2. Evaluate and integrate teaching and learning approaches that support play-based learning in a dynamic and holistic environment, fostering wellbeing, equity, diversity, and inclusion.
- Embed responsive and respectful pedagogies and practices to develop equitable learning environments for children and families from a range of cultural and linguistic backgrounds.
- 4. Apply advanced communication and collaboration skills to build strong and respectful partnerships with stakeholders, including families, colleagues, and communities to support children's wellbeing, learning and development.
- Critically analyse early childhood education and care contexts, and demonstrate leadership, advocacy, reflection, and the application of evidence-based practices that address contemporary challenges and promote equitable outcomes for all learners.
- Engage in critical reflective practice to inform ongoing decision making and continuous professional learning, leveraging evidence-based research, knowledge of curriculum frameworks, legislative and policy requirements, and codes of ethics.

These learning outcomes align with the Australian Qualifications Framework (AQF) Level 8 and are mapped to the Australian Children's Education and Care Quality Authority (ACECQA) standards for early childhood teacher qualification.



Units and Structure

The Graduate Diploma of Early Childhood Education consists of eight (8) core units, each carrying 10 credit points, delivered over two (2) semesters of full-time study. The course is designed to provide both theoretical knowledge and practical teaching experience aligned with national requirements for early childhood educators.

The structure includes two professional experience placements that enable students to gain supervised teaching practice in approved early childhood settings.

Full-time: 1 year (2 semesters)

• Part-time: 2 years (domestic students only)

- ECE406 Diverse Learners and Inclusive Education
- ECE407 Early Childhood Professional Practice 2 (30-day placement)
- ECE408 Leadership and Management in Early Childhood Education



Professional Experience Placement

Professional experience placements are an essential component of the Graduate Diploma of Early Childhood Education. They provide students with an opportunity to integrate theory with practice and gain firsthand experience working in early childhood settings.

Students are required to complete a total of 60 days (equivalent to 480 hours) of placement as part of this course. This includes:

- 30 days with children aged birth to under 3 years, and
- 30 days with children aged 3 to 5 years.

These placements are designed to meet the requirements of the Australian Children's Education & Care Quality Authority (ACECQA) and are aligned with the learning outcomes of the course.

Australis is responsible for organising professional experience placements for all students in partnership with approved early childhood education providers. These placements are arranged to ensure they meet the learning outcomes and regulatory requirements of the course. If a student wishes to organise their own placement at an eligible early childhood setting, they must first contact the Australis academic team to seek approval before making any arrangements.

During placement, students are expected to act professionally at all times, follow directions from supervising teachers, and comply with Australis' policies and procedures, including those relating to conduct, health and safety, and child safeguarding.

Further Study Opportunities

Graduates of the Graduate Diploma of Early Childhood Education may consider further study to advance their professional knowledge or broaden their career opportunities. Some students may go on to undertake postgraduate qualifications such as a Master of Teaching (Early Childhood Education), a Master of Education, or other relevant qualifications in education or related fields offered by other institutions.

Please note that Australis does not offer any formal articulation or credit transfer arrangements into other qualifications. Admission into further study, including potential



credit recognition, is determined by the receiving institution and may vary based on individual circumstances.

If you are considering further study, we encourage you to contact the relevant provider directly. Our team is also available to provide general academic advice and support.

Please note that entry into postgraduate or other higher education programs is subject to the admission requirements of the receiving institution. Australis does not guarantee entry or credit into external programs.

Credit Transfer and Recognition of Prior Learning (RPL)

Australis acknowledges that students may come with prior qualifications or relevant work and life experience. You may be eligible to receive credit towards this course through either credit transfer or recognition of prior learning (RPL), in line with our policies.

Credit transfer applies where equivalent units have been successfully completed at another registered training organisation or higher education provider. RPL considers informal and non-formal learning to determine if it meets the required outcomes.

All applications are assessed on a case-by-case basis. Students wishing to apply should contact Student Services early, preferably prior to course commencement. More information, including application processes and timelines, is available on our website and in the Student Handbook.

You will need to provide certified copies of your academic transcripts, evidence of English language proficiency (if applicable), and a copy of your passport (for international students).

Step 3: Application assessment

Our admissions team will review your application and documents. You may receive a conditional or unconditional offer depending on whether all requirements have been met.

Step 4: Accept your offer and sign your student agreement

Once you accept the offer, you will be sent a written student agreement outlining your enrolment terms, tuition fees and key policies. You must review, sign and return this agreement before proceeding.



Step 5: Pay your tuition fees

After your agreement is received, you must follow the payment instructions outlined in the agreement and pay the required fees by the due date.

Step 6: Enrolment confirmation

After your payment is processed:

- International students will receive a Confirmation of Enrolment (CoE) for visa purposes
- Domestic students will receive formal confirmation of enrolment
